

## 2024 Battle of the Lawyer Bands • August 15, 2024 Rules, Regulations, and Scoring Criteria

#### Who Can Enter/Entry Requirements

- 1) Entrants (i.e., the person filling out the entry form) must have access to an e-mail address for corresponding with the organizers of the event. Entrants must have at least one lawyer or retired lawyer in their band.
- 2) Bands must submit a CD or MP3 to the MBA by May 10, 2024.
- 3) Demo tapes should include all songs (both covered & original tracks) that the band intends to perform at the event. If demo also includes cover songs, please denote ahead of time which tracks are the originals.
- 4) Band contestants must play at least two songs. We encourage bands to play at least one original song.
  - Each band's set should fill approximately 10 minutes, but <u>must not exceed 12 minutes</u>.
  - For every minute over the 12 minutes, there will be a 5 point penalty. The band may also be asked to leave the stage.
  - Bands are allowed a reasonable amount of time for set-up and the timer doesn't start until the first song begins.
- 5) All competing bands are strongly encouraged to invite guests for the advantage of crowd applause and interaction, which will be one of the criteria on which judging is based, in addition to the Audience Choice Award.
- 6) There is a limit to the number of bands that may compete in the competition.
- 7) Any distasteful behavior and/or damage to The Mission Theater will result in automatic disqualification.
- 8) Production equipment (such as fog machines, strobe lights, etc.) needs to be preapproved by the MBA. Contact Kathy Modie (kathy@mbabar.org or 503.222.3275) for approval by August 1. The use of unapproved equipment will result in disqualification.
- 9) Judging is done on a scale of 1–10 by qualified judges. The four judging criteria are explained in detail below.
- 10) An Audience Choice Award will be selected. The winner will be chosen by the crowd, based on individual monetary donations in support of the band. BRING YOUR FANS!
- 11) We require the band to include both instrumental and vocal components. Bands may consist of as few as one or as many as eight performers, provided each performer sings or plays at least one instrument.
- 12) The Battle of the Lawyer Bands Champion will be asked to play an encore for approximately 4 minutes after their victory is announced. Please have another song prepared in the event of VICTORY!

### **Judging Scale and Criteria**

- Music: This criterion is based on musical clarity, lyrical content, musicianship and instrumentation, originality, execution of any cover songs, and overall musical quality and performance. (Judging scale is 1-10).
- Performance: This criterion is based on band's stage presence, performance, theatricality, appearance, personality, and crowd interaction and showmanship.
  (Judging scale is 1-10).
- Crowd Reaction/Participation: This criterion is based on crowd reaction, applause, participation, dancing, etc. (Judging scale is 1-10).
- 4) <u>Lawyer Band Composition</u>: Points awarded based on a percentage (rounded up) of the band's members who are lawyers or legal professionals. (Judging scale is 1-10).

#### **Deductions**

- 1) Time Requirements:
  - a. If a band exceeds 12 minutes of performance time, there will be a 5 point penalty.
  - b. If a band exceeds 13 minutes of performance time, there will be a 10 point penalty.
  - c. If a band exceeds 14 minutes of performance time, they will be disqualified and asked to leave the stage.

#### **Awards**

1) 2024 Battle of the Lawyer Bands Champion

Battle of the Lawyer Bands winner, as chosen by judges based on above criteria.

2) James Britt Award

Individual award for performance, as chosen by judges.

3) Audience Choice Award

Band award, as chosen by crowd (based on individual monetary donations in support of band).



#### **ENTRY AGREEMENT**

third party of an alleged infringement of copyright or any other property right arising out of the display of
artwork. The Artist understands that the display of Artwork on stage is subject to the sole discretion of the
Battle of the Lawyer Bands Committee and any or all of the Artwork may be immediately removed from the
stage at the sole and exclusive discretion of the Battle of the Lawyer Bands Committee.
The Artist also grants the Battle of the Lawyer Bands Committee a nonexclusive, royalty free, perpetual license

to display the Artwork or logo of the band in multimedia. This license and permission to display the Artwork or
logo may be revoked at the sole discretion of the Artist upon written notification to the Battle of the Lawyer
Bands Committee. Battle of the Lawyer Bands Committee will remove the Artwork or logo from its multimedia
sources within a reasonable time after receipt of written notice of revocation of the license.
I, also grant the Battle of the
Lawyer Bands Committee the right to use my name, voice, image of physical likeness, biographical material,
contact information, and any other information in the multimedia to promote the Battle of the Lawyer Bands
competition.
