<u>PHILOSOPHY AND APPROACH:</u> I am employed as Senior Attorney Counselor for the Oregon Attorney Assistance Program (OAAP). The services I provide at the OAAP are intended to: (1) assist Oregon lawyers, judges, law students, and legal professionals to achieve a desired state of well-being, (2) respond to calls of concern regarding a third party who may benefit from OAAP services, (3) provide referrals and recommendations for professional community resources, (4) provide educational and resource services, and/or (5) generally respond as needed and appropriate to those seeking OAAP assistance.

Regarding those seeking improved well-being for themselves, I consider that each person comes to OAAP with their own unique history and background. I believe that the ways in which one generally deals with life's challenges, with our relationships, and with our personal, professional, and social environments, is broadly influenced by, and a reflection of, how they typically think, feel, and behave in their lives, especially during times of stress, anxiety, conflict, disappointment, grief, and other such life experiences.

My professional focus with each person seeking services is to provide a meaningful working relationship where trust, confidence, safety, and hope can be established, strengths can be examined, and goals can be identified and addressed. I work collaboratively with each person, and, when appropriate, explore personal and professional life experiences, trauma-related and otherwise, as well as patterns of thinking, feeling, and behaving, in order to assist in facilitating the goals and positive changes being sought, including encouraging use of appropriate self-help tools and resources.

EDUCATIONAL AND PROFESSIONAL BACKGROUND: I hold a Bachelor of Science degree from the University of Oregon, Doctor of Jurisprudence degree from the University of Oregon School of Law, and a Master of Arts degree in Counseling from George Fox University. My graduate school course work included Human Growth and Development, Marriage and Family Therapy, Advanced Marriage Therapy, Personality and Counseling Theory, Human Sexuality, Psychopathology, Group Therapy, Substance Abuse, and Addiction Pharmacology.

I have been a Board Certified Addiction & Drug Counselor since 2007 (CADCI). I am educated, trained, and experienced in working with individuals struggling with, or seeking information concerning, problematic substance use. Additionally, I have served as an Adjunct Professor at both Portland State University and the Department of Counseling at George Fox University. I have presented dozens of continuing education programs to Oregon mental health professionals regarding clinical ethics and professionalism (2006-2020). During my OAAP career, I have also made numerous informational and continuing legal presentations to lawyers, judges, law students, law firms, state and county bar organizations and others, primarily regarding professional well-being, problem substance use, and mental health issues.

<u>BILL OF RIGHTS:</u> I adhere to the standards established by the Oregon Board of Licensed Professional Counselors and Therapists, as well as the statutes, regulations, bylaws, policies, and accepted practices of the Oregon State Bar, Oregon Professional Liability Fund, and the Oregon Attorney Assistance Program. Consumers of professional services offered by OBLPCT Licensees, have the following rights:

- To expect that a licensee has met the minimal qualifications of training and experience required by state law;
- To examine public records maintained by the Board and to have the Board confirm credentials of a licensee;
- To obtain a copy of the Code of Ethics;
- To report complaints to the Board;
